- Non Pro – Any handler who does not receive remuneration of any kind for training dogs.
- .....\$100 + 5 Sanction Fees = \$105

Handlers meeting 7:30 a.m. All handlers must compete horseback. Three dog limit per class or until trial is full at max 45 runs per day. Dry camping is available and some pens.

Buckles to be awarded to most points accumulated in each class by a team at end of series 50% payout day monies.
