Rodear competition starts immediately following the 8:00AM Handler's Meeting. All handlers must be horseback, all breeds welcome. All classes are jackpot classes and a champion buckle will be awarded at the completion of the series to each class based on the dog with the highest points awarded. To qualify for the buckle, the handler/dog team must compete in 4 of the 6 trials offered. Number of places paid will be one place for every five dogs entered. Entries are capped at 15 dogs per class per day. Classes will be scored by point and time; any ties will be broken by the sort time. Please return entry with signed release and payment for fees. Entries will be closed once we reach class capacity or 8am the day of the event; if entering day of, please call ahead to ensure we have space, all day of fees must be paid in cash. All dogs must be on a leash. Spectators are free of charge. Dry camping is available and stalls are available for an additional fee of \$25 per night, please note if you will need a stall and or camping on your entry.
