****Open Division:** This class is for any dog and any handler.

****Non-Pro Division:** This class is for individuals who do not receive remuneration for training dogs. Any dog may compete in this division.

****Green Dog Division:** This class is intended for young and/or inexperienced dogs that are not ready to compete in the other Rodear classes offered. Once a Green Dog has won a Green Dog Rodear class two (2) times, the dog must move up to the other Rodear divisions.

****Beginner Division:** This class is for inexperienced handlers who have not competed in cow dog competitions. After an individual has won a Beginner Rodear class three (3) times, he or she must move up to the other Rodear divisions.

Waiver and Release: I understand that herding is a strenuous sport and a potentially hazardous activity and I state that my animals and I are in proper physical condition for this event. I also accept any and all other risks associated with the trial including, but not limited to falls, contact with the livestock, the effects of the weather and any potentially hazardous conditions associated with the trial site. Knowing these facts, and in consideration of you accepting my entry, I hereby for myself, my heirs, executors, administrators, assigns, or anyone else who might try to claim on my behalf, covenant not to sue, and waive, release and discharge all host and sponsors, including, but not limited to the property owners of the events, or any employees of the property owners, Willoughby Ranch, owners or family members of Willoughby Ranch, Rodear America or its directors, officers, members, agents, assigns and anyone acting for or on its behalf from any and all claims of liability, death, personal injury or property damage of any kind or nature arising out of or in the course of my participation in this event.
